MP Sign-On Letter

About the Letter

This sign-on letter, calling for a full and immediate arms embargo on Israel, was initiated by the following organizations: the Palestinian Youth Movement (PYM), Canadians for Justice and Peace in the Middle East (CJPME), Independent Jewish Voices (IJV), the Palestine Solidarity Network, World BEYOND War, Labour 4 Palestine, and Labour Against the Arms Trade (LAAT).

Among others, the signatories of the organizational sign-on letter include: the United Church of Canada, the Canadian Muslim Public Affairs Council (CMPAC), the Anglican Church of Canada, the Canadian Union of Postal Workers (CUPW), the Canadian Union of Public Employees (CUPE), the National Union of Public and General Employees (NUPGE), the Public Service Alliance of Canada, Leadnow, International Civil Liberties Monitoring Group, Greenpeace Canada, Canadian Council for Refugees, Canadian Centre for Policy Alternatives, Ontario Health Coalition, Indigenous Climate Action, and the United Network for Justice and Peace in Palestine and Israel (UNJPPI).

ENGLISH SIGN-ON LETTER

As the catastrophe wrought by Israel's continued assault on Gaza grows, we— the undersigned Members of Parliament— join Canadian civil society organizations representing millions of Canadians across the country in calling on the Canadian government to immediately suspend all trade in arms and military technology with Israel.

The Government of Canada defines an arms embargo as a sanction that “aims to prevent weapons and military equipment from leaving or reaching a targeted country. It prohibits exporting and importing arms and related materials to and from the targeted country, and may also prohibit communicating technical data or financial transactions related to military activities.”

Under the Special Economic Measures Act, Canada can and should also ban the export to and import from Israel of surveillance, security, and intelligence technologies, as well as a broad range of dual use items (electronics, computers, sensors, lasers, avionics, etc.) that may not be considered strictly “military” in nature but are integral to Israel's siege and assault on Gaza and its continual annexation of the occupied Palestinian territories.

Ending Canadian arms exports to Israel may impact some workers in the arms and technology industries. We urge the government to work with trade unions representing these workers to develop short and long term plans for a just transition that will secure their livelihoods and enable them to work without the fear of being complicit with Israel's war crimes and possible genocide in Gaza.

We call on the Canadian government to uphold its moral and legal responsibilities and impose a full and immediate arms embargo on Israel.
